Explanation of significant increases in the budget:

Property tax valuations for FY24 slight increase so general, civic center and emergency levies increased. Liability, Property & Self-Insurance levy increased due to cost of property insurance. Increase in employee benefits due to increase in health insurance premiums and workers comp premiums.
